Current and projected shortage of direct care workers (Direct Support Professionals) in Kansas – Allen Schmidt

Allen Schmidt emphasized how there will be a projected 74,000 job openings for personal care aides, home health aides and nursing assistants. Two bills in the house addressing the DSP's and there shortages. Direct support workforce crisis puts people needing assistance at great risk of harm, denials of services, and longer waiting lists.

Define the capable person policy in regard to the care of our disabled kids and adults in need of care per their personal care plans – Ed Nicholas

Ed Nicholas expressed concern for families with the changes made in 2016 on the capable person policy.
