

Home & Community Based Services (HCBS)



- HCBS waiver programs ensure the right supports and services are provided for our members:
 - Elderly individuals
 - Persons with disabilities
- These services are provided by our network partners in the member's home, the community or in a facility
- Sunflower care managers and staff focus on integrated care for the member's medical, behavioral, and community-based services

- Also referred to as "Extra Services" or "Value Added Services"





Dental

- ☐ Two dental visits (cleanings, screenings) for adults 21 years and older every year
- ☐ Children are covered for most dental services under regular Medicaid benefits
- □ Practice visits for Intellectually/Developmentally Disabled (IDD) and Autism Waivers
- □ Dentures may be covered for Frail and Elderly Waiver members







- Free Smartphone through SafeLink®
 - 350 free minutes and unlimited texting
 - 1GB of data the first three months, then 500MB each month after
- Smoking Cessation Program
- Choose Health Program
 - Chronic health conditions, managing emotions

Extra Services Healthy Rewards Program



- Members can earn \$10-50 for certain doctor visits
 - ☐ Immunizations for children and adolescents
 - ☐ Diabetes check-ups
 - ☐ Prenatal and postnatal visits
 - ☐ Cervical cancer screening
 - ☐ Plus more
- Rewards are used to buy from hundreds of items at participating retail stores such as CVS Pharmacy, Dollar General and Walmart.
- Qualifying purchases, examples:
 - Baby care, diabetes care, digestive health, eye & ear care, fitness & wellness, foot care, first aid, groceries, home care such as air purifiers, household products like pesticides, and OTC (over-the-counter) medications

Extra Services New for 2019



Nursing Hometo-Community Transition Support

Partnering with providers to:

- Conduct pre-placement transition meetings and activities such as finding and securing housing, securing house-hold items, confirming informal supports, completing in-home risk assessment, and assisting with hiring of caregivers.
- Follow-up visits to ensure services and equipment are in place and meeting the member's needs, to confirm or set up a PCP appointment, among other personal support activities
- Cover 1 week of home-delivered meals for each member transitioning out of a nursing facility regardless of waiver benefit coverage.

Members may be eligible for additional financial assistance or benefits, based upon need, when transitioning to independent living situations.

Caregiving Collaborations®

Caregivers are supported in the Caregiving Collaborations program. This benefit is available to one primary, informal support caregiver per member. Benefits include the Caregiver Resource Center and a Caregiver Journal. In addition to the program benefits, each member and caregiver will continue to receive coordination of respite services available through the individual care plan.

Extra Services New for 2019



Parent Management Training – Oregon Model (PMTO)

Extra support to Foster Care families and agencies through nationally recognized Parent Management Training program. The goal is to enhance stability in the home. This program is ideal for many families because it is known to strengthen interventions that address conduct, social behavior and other associated symptoms.

"Care Grants" for Children in Foster Care

Care Grants benefiting children in Foster Care. Sunflower will provide care grants to be used in helping members in Foster Care access person-specific resources that are not covered by Medicaid, such as hypo-allergenic sheets for those with asthma, art supplies, clothing, camp fees or other personal items.

Employment Support & Transportation

Sunflower Transition to Employment Program (STEP) is a workforce development and employment support resource program. We help members identify and remove employment barriers. Benefits include enhanced transportation coverage, GED prep test vouchers, and assistance with career counseling services. Members are connected with a benefits specialist to learn how their income may impact their benefits, as well as to learn about the STEP Scholarship program.

Enhanced Transportation for F/E & PD

Enhanced transportation to local community events and social activities for members receiving Frail & Elderly (F/E) and Physical Disability (PD) waiver benefits. This benefit includes three round trips a year.
