<b>RE: Summary of Changes (SOC) for KFMAM Revision #30</b>	<b>Program(s): MAGI</b>

The purpose of this document is to identify the changes which have been made to the KFMAM effective December 01, 2020. Changes are outlined below.

## **A. MANUAL SECTION KFMAM**

**2240.01**     **Eligibility Requirements** – Updated Extended Medical (EXT) criteria to specify an increase in spousal support received as the result of a divorce decree finalized or modified after December 31, 2018 only.

**05200**     **Unearned Income** – Added reference 5214 regarding lump sum budgeting.

**05300**     **Earned Income** – Added reference 5314 regarding lump sum budgeting.

**5220**     **Countable Unearned Income** – Updated reference 5220.16 for spousal support to specify support received from a divorce decree prior to December 31, 2018 only. Updated reference 5220.06 for lottery and gambling winnings of over \$80,000 received as a one-time payout as this income is now countable under qualifying circumstances and using specific conversion rules.

**05400**     **Exempt Income** – Added clarifying language to include three types of non-taxable income that are considered countable, those being non-taxable Social Security, non-taxable foreign earned income, and tax-free interest (previously it only stated Social Security). Added new reference 5452 for spousal support received as the result of a divorce decree finalized or modified after December 31, 2018.

**5440**     **Lump Sums** – Lump sum income is countable in the month received if the income is taxable. Removed previous 5440 and subsections and added references 5214 and 5314 regarding lump sum income. Replaced 5440 with policy relating to exempt discharged, forgiven, or cancelled student loan debt.
