What is Electronic Visit Verification

Electronic visit verification (EVV) utilizes mobile-based technology to validate caregiver visits by capturing visit data as required by section 12006 of the 21st Century Cures Act. KDADS first implemented EVV for Home and Community Based services in 2012. CMS requires the State of Kansas to have EVV for HHCS implemented by January 1, 2024.



Electronic Visit Verification (EVV) Systems must verify:


- Type of service performed.
- Individual receiving the service.
- Date of the service.
- Location of service delivery.
- Individual providing the service.
- Time the service begins and ends.

The State of Kansas also requires:

Caregiver observations.








Claims Processing – Submit to KMMS






KanCare KMMS Submits Claims to MCOs
